

Provincial Agricultural Land Commission - Staff Report Application: 52825

Applicant: Copper Seven Enterprises Inc.

Proposal: Pacific Coast Fruit Products Ltd. is seeking permission to use an existing receiving, freezing

and packing facility located on the subject property for the processing of fruit. The

operators are also applying to continue using a residence on the property as an office (the

conversion of which has already been mostly completed).

BACKGROUND INFORMATION

The applicants purchased the subject property in 2008 because of the existing facility. In 2009, Thomas Loo (ALC Compliance and Enforcement Officer) investigated the operation on the subject property as to whether or not it was compliant with Section 2(2)(c) of the Agricultural Land Reserve Use, Subdivision and Procedure Regulation (the "Regulation"). Based on the information provided by the applicants, the ALC concluded that the operation was compliant with the Regulation. However, in 2011, the BC Farm Industry Review Board found that the applicants were not operating in a manner consistent with the Regulation. As a result, the applicants have submitted a nonfarm use application to the ALC.
