The Commission draws your attention to Section 33(1) of the *Agricultural Land Commission Act* which provides an applicant with the opportunity to submit a request for reconsideration based on specific criteria.

- 33(1) On the written request of a person affected or on the commission's own initiative, the commission may reconsider a decision of the commission under this Act and may confirm, reverse or vary it if the commission determines that:
- (a) evidence not available at the time of the original decision has become available,
 - (b) all or part of the original decision was based on evidence that was in error or was false.

A revised proposal does not constitute new evidence and as such is not a basis for reconsideration. The time limit for submitting a request for reconsideration is one (1) year from the date of this letter.

PROPOSAL

To subdivide the subject 3.5 ha parcel into one (1) 1.13 ha lot and one (1) 2.37 ha lot.
(Submitted pursuant to section 21(2) of the *Agricultural Land Commission Act*)

LEGISLATIVE CONTEXT FOR COMMISSION CONSIDERATION

Section 6 (Purposes of the commission) of the *Agricultural Land Commission Act* states:

- 6 The following are the purposes of the commission:
- (a) to preserve agricultural land;
 - (b) to encourage farming on agricultural land in collaboration with other communities of interest; and
 - (c) to encourage local governments, first nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

COMMISSION CONSIDERATION

After considering the information the Commission concluded as follows:

1. The proposal to subdivide a 1.13 ha portion from the subject 3.5 ha parcel in order to create a new rural residential lot under section 21(2) of the *Agricultural Land Commission Act*.

Conclusion:

The Commission assessed the impact of the proposal against the long term goal of preserving agricultural land. In the Commission's view, reduction of parcel size generally reduces the available options for agricultural use. The Commission believed that the

subject property has more agricultural potential as it currently exists and that the proposed subdivision would negatively impact the agricultural opportunities available to the subject property in the long-term.

Further, the Commission noted the subject property is located within a large block of ALR land and the proposal, if permitted, has the potential to raise area landowner expectations that further subdivision may be permitted. Heightened expectations have the effect of attracting landowners whose interests may be focused on future subdivision rather than agricultural activity.

The intent of the Act is to preserve and protect agricultural lands and farm communities in the long-term and the Commission felt that subdivision of the subject property as proposed was not in keeping with that mandate.

THAT the application to subdivide the subject 3.5 ha parcel into one (1) 1.13 ha lot and one (1) 2.37 ha lot be refused.

AND THAT the applicant be advised that a revised proposal does not constitute new evidence and will not be considered as a basis for reconsideration, that the time limit for submitting a request for reconsideration is one (1) year from the date of the decision letter, and that if the applicant sells or transfers the property within one (1) year of the decision the new owner is not eligible to submit a request for reconsideration.
