MINUTES OF THE PROVINCIAL AGRICULTURAL LAND COMMISSION

PROPOSAL (Submitted pursuant to section 21(2) of the Agricultural Land Commission Act)

To subdivide a 10 ha portion from the 27.6 ha subject property as divided by a creek. The remaining 17.6 ha is to be consolidated with District Lot 5805 to the south.

SITE INSPECTION

A site inspection was conducted on June 25, 2013. Those in attendance were Commissioner Thibeault, ALC Planner Reed Bailey, Ministry of Agriculture Resource Agrologist Darrell Smith, and Mr. Perry Rammeloo representing the applicants.

During the site inspection, the initial proposal for subdivision and exclusion of the 10 ha portion was discussed and amended to a subdivision application. Mr. Rammeloo also advised that the remainder (17.6 ha) would be consolidated to DL 5805, adjacent to the south.

Section 14(2) of the Agricultural Land Commission Act provides that a member of the Commission who was not present at a meeting to determine an application or other matter may vote on the application or matter only if a summary of the meeting is given to the member before the vote. Commissioner Thibeault gave a verbal summary of the site inspection to all Commission members recorded above.

LEGISLATIVE CONTEXT FOR COMMISSION CONSIDERATION

Section 6 (Purposes of the commission) of the Agricultural Land Commission Act states:

- 6 The following are the purposes of the commission:
 - (a) to preserve agricultural land;
 - (b) to encourage farming on agricultural land in collaboration with other communities of interest; and
 - (c) to encourage local governments, first nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

COMMISSION CONSIDERATION

After considering the information the Commission concluded as follows:

1. The subject property is physically divided by a water course.

Conclusion: The proposed subdivision will follow the physical divide.

The portion of the subject property lying south of the creek is proposed to be consolidated with the adjacent property.

Conclusion: The proposed subdivision will not result in any new lots.

THAT the proposal to subdivide the 27.6 ha property into two lots as divided by the creek be approved subject to:

- 1. The consolidation of the southern remainder with District Lot 5805, Kootenay District; and
- 2. The subdivision plan must be completed within three (3) years from the date of this decision;

AND FINALLY THAT this decision does not relieve the owner or occupier of the responsibility to comply with applicable Acts, regulations, bylaws of the local government, and decisions and orders of any person or body having jurisdiction over the land under an enactment.
