DECISION:

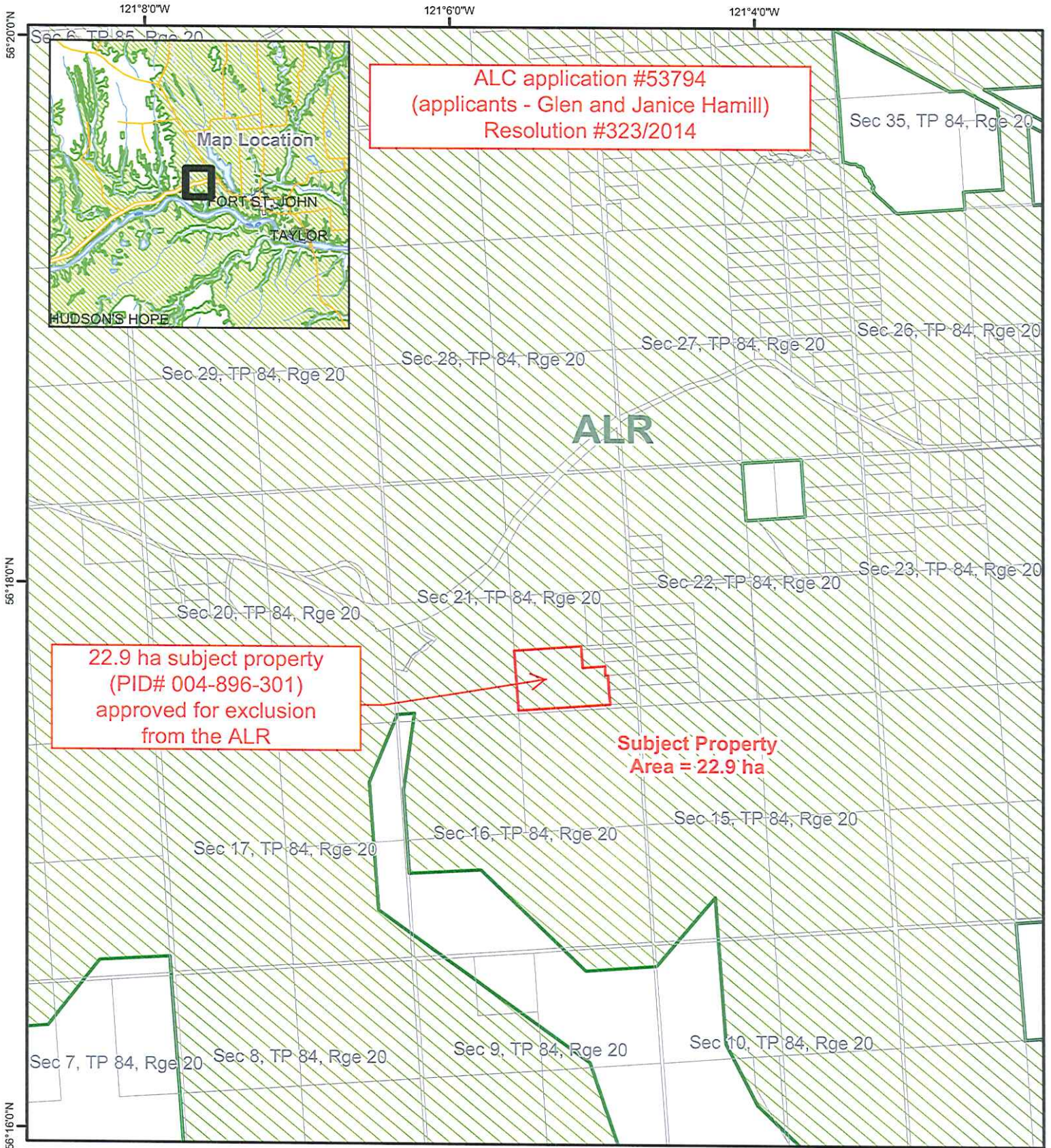

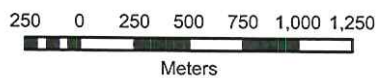
