

The date an application was submitted to the local government in the ALC Application Portal determines how much the application fee is, what the split between the local government and the ALC is, and who collects what portion of the fee. Local governments may have applications in all of these payment scenarios as older applications are reviewed by your board/council and processed.

Please refer to the table below when receiving and forwarding applications to confirm which application fee instructions to follow. Refer to the 'Date submitted to LG' column in the Local Government Inbox in the Portal. If the local government receives the Total Application Fee for an application, the local government must remit the ALC's portion of the fee.
