The Provincial Agricultural Land Commission (the "Commission") has now concluded its review of your application to utilize the ALR portion of the above noted property for a "play structure, chip pathways, a 1.0 ha playing field with soccer goals, baseball backdrop, irrigation system and sub-soil drainage." In addition, the proposal is to place 4300 cubic meters of soil over a 1.25 ha portion of the property to a depth ranging from 0.3 to 0.45 meters. The application was submitted pursuant to section 20(3) of the *Agricultural Land Commission Act* (the "ALCA").

The Commission wishes to thank you for taking the time to meet with its representatives on 18 April 2006. The Commission found the meeting and site visit informative.

The Commission writes to advise that it approved your application in principle subject to:

- a consultant having the appropriate academic and work credentials in soil science (i.e. Land Reclamation Specialist with knowledge in soil physics, drainage, irrigation and a good understanding of filling operations) be hired to prepare a report for a plan to fill the above noted property as proposed. The Commission expressed a particular need for a hydrology assessment of the project and a plan to ensure that the subject property will be properly drained and will not have an adverse effect on the adjacent farm to the north or on surrounding neighbours.
- final approval of the application will be given upon receipt and endorsement of this report.
- compliance with applicable Acts, regulations, bylaws of the local government, and decisions and orders of any person or body having jurisdiction over the land under an enactment. The Commission suggests you contact the District of North Saanich at your earliest convenience.

For Consideration

Ron Wallace presented his staff report dated 4 April 2006 regarding application #C-36538-0, Board of School Trustees of School District #63. The application is twofold:

- 1) To utilize the ALR portion of the property for a "play structure, chip pathways, a 1.0 ha playing field with soccer goals, baseball backdrop, irrigation system and sub-soil drainage".
- 2) To place 4300 cubic meters of soil over a 1.25 ha portion of the property to a depth ranging from 0.3 to 0.45 meters.

Site Inspection

A site inspection was conducted on 18 April 2006. Those in attendance were:

- Commissioners Seitz, Craven & Rugg
- Agricultural Land Commission Staff: Ron Wallace, Regional Research Officer and Roger Cheetham, Planner
- Applicants: Joan Axford, Secretary-Treasurer, Saanich Schools and Jim Partlow, Landscape Architect.

The site inspection lasted from 9:00 a.m. to 9:30 a.m.

Commission Discussion

In reviewing the application the Commission noted that the School District has owned the property since 1964 and that the ALR portion of the property has been informally used for playing fields since 1970 with the construction of the Recreational Centre to the south. In addition, the Commission was aware of the concerns of this application from a neighbor who lives on the adjacent property to the north. In light of the above, the Commission approved the application in principle subject to a consultant having the appropriate academic credentials in soil science being hired to prepare a report for a plan to fill the property as proposed. The Commission expressed a particular need for a hydrology assessment of the project and a plan to ensure that the subject property will be properly drained and will not have an adverse effect on the adjacent farm to the north or on surrounding neighbours. The Commission would be prepared to give final approval upon the receipt and endorsement of this report.

PROPOSAL:

The subject property is 4 ha with approximately 2/3 of its eastern portion,

±2.7 ha, being within the ALR. The application is twofold:

1) To utilize the ALR portion of the property for a "play structure, chip pathways, a 1.0 ha playing field with soccer goals, baseball backdrop,

irrigation system and sub-soil drainage".

2) To place 4300 cubic meters of soil over a 1.25 ha portion of the property

to a depth ranging from 0.3 to 0.45 meters.

This application is made pursuant to section 20(3) of the Agricultural Land

Commission Act.

BACKGROUND INFORMATION:

There have been no previous applications on the subject property. The School District purchased this property in 1964 and at that time it was zoned Institutional. The lower 2/3 of the property was placed in the ALR in 1973.

The Commission has received correspondence from a neighbor who lives on the adjacent property to the north of the subject property. This neighbor is an organic farmer who has produced various crops including garlic and small potatoes. Their main objection to the development is with the placement of the proposed elementary school on the western treed portion, lying outside the ALR, of the subject property. It is their concern that water run-off will flow from the proposed school site, sitting on higher ground, towards their farm that lies below. Staff at the District of North Saanich is aware of this concern and has proposed the creation of a vegetative buffer area between the two properties to help mitigate the potential excess water problem.

The eastern 2/3 of the property lying within the ALR is a flat field. The western 1/3 of the property lying outside of the ALR is treed with sloping topography and rocky soil conditions.

The property has always been zoned for school use as it has been owned by the School District since 1964.

LOCAL GOVERNMENT RECOMMENDATIONS/COMMENTS:

Local Council

On February 20, 2006 the North Saanich Council adopted a resolution authorizing staff to forward the application to the Commission.

Local Government Staff

The Planning staff has indicated that the School District has owned this property since 1964 and since 1970 has been used informally for field sports with the construction of the Recreation Centre to the south.

STAFF COMMENTS:

Staff recommends that the Commission consider the following:

- The School District has owned the subject property since 1964.
- The land has been zoned for school use since the inception of the District of North Saanich in 1965.
- The ALR portion of the property has been informally used for playing fields since 1970 with the construction of the Recreational Centre to the south.
- As the proposal is to utilize the ALR portion of the property just for playing fields, with no structural development, the land could be redeveloped for farm use in the future.
- Staff recommends an on-site to determine if there are additional measures the Commission can take to mitigate the concerns of the farmer to the north.
