Site Inspection

A site inspection was conducted on 10th January 2007. Those in attendance were:

- Commissioners Seitz, Craven and Rugg
- · Roger Cheetham, Regional Planner
- Laurie Gourlay and Jackie Moad

The Commission noted that since its previous site inspection of the property on 5th June 2006 additional work had been carried out. The Commission also noted that the conversion of the barn would have minimal impact on agriculture.

Context

The proposal was weighed against the purposes of the Commission as stipulated in section 6 of the Agricultural Land Commission Act (the "Act"). They are:

- 1. to preserve agricultural land
- 2. to encourage farming on agricultural land in collaboration with other communities of interest, and
- 3. to encourage local governments, first nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

Discussion

There was some debate with regard to the level of agricultural activity and the justification for additional farm help. While the Commission had reservations in this regard it also noted that there was unlikely to be any material impact on agriculture resulting from the conversion of the barn provided that the second dwelling was occupied by someone providing farm help and provided also that no expansion of the dwelling occurred.

THAT the Commission considered that new evidence had been received that provided grounds for the reconsideration of the application.

THAT the reconsideration request be approved subject to the second dwelling being confined to the existing barn and no further extensions being carried out and provided further that the second dwelling is occupied by someone providing farm help for the farming operations taking place on the property.

This decision does not relieve the owner or occupier of the responsibility to comply with applicable Acts, regulations, bylaws of the local government, and decisions and orders of any person or body having jurisdiction over the land under an enactment.
