**PROPOSAL:** To deposit fill (i.e. clay and top soil) over approximately 0.28 ha of the

subject property in order to level low lying areas that are subject to standing water. The proposal is to add approximately 2800 cubic meters of fill to

make the site more productive for blueberries.

This application is made pursuant to section 30(1) of the Agricultural Land

Commission Act.

# **BACKGROUND INFORMATION:**

There have been no previous applications for this property but there has been a history of illegal filling occurring on this property. Since May 2005 there have been three Stop Work Orders issued to Mr. Serjit Gill relating to this illegal dumping activity. After the third Stop Work Order in August 2007, representatives from the Township of Langley met with the owner of the Operations Yard to explain that a soil deposit application is required. A copy of Timeline of Events prepared by the Township of Langley is attached.

## **STAFF COMMENTS:**

Staff recommends an onsite to determine whether there are other more preferable options available to deal with excess water issues than placing fill. Evidence submitted with the application (e.g. photographs and maps) indicates that the property has some undulating topography which may be remedied by simple ditching and drain tiles rather than the placement of fill.
