Site Inspection

No site inspection was conducted.

However a meeting was held on Tuesday, November 3, 2009 at the Ministry of Environment Offices located in Cranbrook, attended by the Commissioners and staff noted above, and Bob Holby, the agent for the applicant. At the meeting the agricultural capability of the property was discussed as were the impacts of the potential exclusion and development on the agricultural utility of the surrounding lands.

Context

The proposal was weighed against the purposes of the Commission as stipulated in section 6 of the *Agricultural Land Commission Act* (the "Act"). They are:

- 1. to preserve agricultural land
- 2. to encourage farming on agricultural land in collaboration with other communities of interest, and
- 3. to encourage local governments, first nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

Discussion

Assessment of Agricultural Capability and Suitability

In assessing agricultural capability, the Commission refers in part to agricultural capability mapping and ratings. The ratings are interpreted using the Canada Land Inventory (CLI), 'Soil Capability Classification for Agriculture' system.

The unimproved agricultural capability of the soil of the subject property is;

Class 5 – Land in this class has limitations that restrict its capability to producing perennial forage crops or other specially adapted crops.

The limiting subclasses are stoniness and seasonal moisture deficiency.

The Commission believed that the land had very limited capability or suitability for agricultural development because of poor soils, the small ALR area, and the debilitation resulting from the historic sawmill use.

Assessment of Impact on Agriculture

The Commission also assessed the impact of the proposal against the long term goal of preserving agricultural land. The Commission believes the proposal would not affect the existing or potential agricultural use of surrounding lands because the 3.6 ha area is separated from other farmlands by the Kettle River.

Conclusions

- That the land under application has very limited agricultural capability and is unsuitable for agricultural uses.
- 2. That the exclusion proposal will not impact agriculture.


