On November 2, 2009 the Commission delegated decision-making to the CEO by Resolution #005N-2009 (Files: 135-45/ALC/CEO/APPL and Planning Review 57-O-MUO-1997-31576). In accordance with section 27 of the *Agricultural Land Commission Act* the Commission has specified that in conjunction with the review by Chief Executive Officer Erik Karlsen of certain matters delegated to him under criterion 4 of Resolution #003N-2009, more specifically non-farm use applications made pursuant to section 6(c)(ii) or section 6(d) of BC Regulation #171/2002 (ALR Use, Subdivision and Procedure Regulation) in respect of lands within the District of Maple Ridge or the City of Pitt Meadows, he may also decide any such application which also involves the subdivision of land in a manner integral to the purpose of establishment or modification of a recreational trail.
