- **PROPOSAL:** To establish and operate an anaerobic digester on the subject property. The digester will produce "biogas" (natural gas) primarily from dairy manure from the farm, and to a lesser extent, alternative feedstocks such as whey, bakery byproducts and food waste. The proposed operation will also produce residual products such as animal bedding and fertilizer as a by-product of the digesting process.

# **STAFF COMMENTS**

As outlined under relevant applications, the Commission approved a similar application for an anaerobic digester in 2008. This application was allowed provided the feedstock for the digester was consistent with a proposed Nutrient Management Plan.

The subject applicant has partnered with Avatar Energy Corp. which specializes in the design,

construction and service of biogas plants. This company has been involved in the establishment of biogas facilites in North America.

The agricultural waste that will be processed at this facility will primarely consist of manure from the dairy operations and alternate digester feedstocks such as whey, bakery byproducts and food waste. The applicant anticipates that the proposed anaerobic digester will offset farm operating cost. The residual by-products of the digestion process will be animal bedding and improved fertilizer.

The Council of the City of Abbotsford has recommended support for the application as did the Agricultural Advisory Committee.

A letter of support was received from the Anaerobic Digestion Advisory Committee (ADIAC). This letter indicated that the anaerobic digestion technology that Bakerview EcoDairy Ltd is proposing to adopt is unique in that its cost effective modular design makes it suitable for small to medium sized dairy farms, as small as 75 - 100 head instead of the traditional 500+ head. This is important in BC, as the average herd size of BC's 542 dairies is approximately 124 head (see attached letter).

In regard to agri-tourism activities taking place at Bakerview EcoDairy, the City of Abbotsford has issued permits and variances to ensure consistency with its bylaws as it believes that the activity is consistent with ALC Act regulations. ALC staff have reviewed the agri-tourism proposal and have advised that agri-tourism activity proposed, including the farm retail sale component, is consistent with the regulations.
