# APPLICATION ID: #52514

**PROPOSAL:** To subdivide the subject property into two lots of approximately 20 ha and 23 ha. The applicant is seeking approval for subdivision in order to settle with an ownership partner who has requested to be bought out, or provided with land. (Submitted pursuant to section 21(2) of the *Agricultural Land Commission Act*)

#### COMMISSION CONSIDERATION:

Section 6 of the *Agricultural Land Commission Act* identifies the purposes of the Commission are (1) to preserve agricultural land; (2) to encourage farming on agricultural land in collaboration with other communities of interest; and (3) to encourage local governments, first nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

After review of all file information presented the Commission has concluded as follows:

- There are no external factors that render the land unsuitable for agricultural use. The
  presence of non-ALR land to the north and south of the subject property
  does not impede the use of the land for agriculture;
- That the proposal will adversely impact agriculture by fragmenting useful agricultural land into two parcels. It is believed the subject property has greater potential for agriculture as one parcel than as the proposed two parcels.
- 3. The proposal will raise expectations for further parcelization of ALR lands in the immediate area:
- 4. That the proposal is inconsistent with the objective of the *Agricultural Land Commission Act* to preserve agricultural land.
