LEGISLATIVE CONTEXT FOR COMMISSION RECONSIDERATION

Section 33 (Reconsideration of decisions) of the Agricultural Land Commission Act states:

- 33(1) On the written request of a person affected or on the commission's own initiative, the commission may reconsider a decision of the commission under this Act and may confirm, reverse or vary it if the commission determines that:
 - (a) evidence not available at the time of the original decision has become available,
 - (b) all or part of the original decision was based on evidence that was in error or was false.

DECISION REGARDING THE REQUEST FOR RECONSIDERATION

Your request and the file material were reviewed by the Commission and it was determined that your submission did not contain new evidence that was unavailable at the time of its original decision, nor did you provide evidence that the decision was based on information that was in error or false. As such, your submission does not meet the requirements of Section 33 of the *Agricultural Land Commission Act* and therefore a reconsideration is not appropriate. The original decision under Resolution #189/2012 remains in effect.
