Re: Application to Construct a Second Dwelling on Land in the Agricultural Land Reserve

The Commission draws your attention to Section 33(1) of the *Agricultural Land Commission Act* which provides an applicant with the opportunity to submit a request for reconsideration based on specific criteria.

- 33(1) On the written request of a person affected or on the commission's own initiative, the commission may reconsider a decision of the commission under this Act and may confirm, reverse or vary it if the commission determines that:
 - (a) evidence not available at the time of the original decision has become available,
 - (b) all or part of the original decision was based on evidence that was in error or was false.

A revised proposal does not constitute new evidence and as such is not a basis for reconsideration. The time limit for submitting a request for reconsideration is one (1) year from the date of this letter.

PROPOSAL (Submitted pursuant to section 20(3) of the Agricultural Land Commission Act)

To approve an existing second dwelling for farm help on a 1.5 ha property. The applicant states that they require live-in farm help to care for approximately 13 to 16 draft horses.

LEGISLATIVE CONTEXT FOR COMMISSION CONSIDERATION

Section 6 (Purposes of the commission) of the Agricultural Land Commission Act states:

- The following are the purposes of the commission:
 - (a) to preserve agricultural land:
 - (b) to encourage farming on agricultural land in collaboration with other communities of interest: and

(c) to encourage local governments, first nations, the government and its agents to enable and accommodate farm use of agricultural land and uses compatible with agriculture in their plans, bylaws and policies.

COMMISSION CONSIDERATION

After considering the information the Commission concluded as follows:

 Prior to 2013 there was one dwelling on the subject property which was the original farm house. The original farm house is located on the north side of the property with its own driveway access. In 2013, a new home was built to accommodate the applicants growing family and the old farm house was scheduled for decommissioning to be used as storage.

At the time of construction of the new house, the applicants were aware that only one dwelling is permitted within the ALR unless authorized by the local government for farm purposes or by the Commission through the non-farm use application process. The applicants chose to commit to decommissioning the old farm house in order to construct the new house.

The Commission is now in a position whereby two dwellings are constructed on the property and the Commission is being asked to approve a second dwelling which the applicant had agreed to remove in order to construct the new house.

Conclusion:

The Commission's Policy 10 BUILDING NEW RESIDENCE WHILE OCCUPYING EXISTING RESIDENCE (2003) provides that a non-farm use application is not required to build a new house while occupying an old house. It appears the District of Central Saanich issued a building permit in accordance with Policy 10 as the owners committed to decommissioning the old farm house in order to construct the new house.

2. The applicants run a full-time equestrian operation where they train, sell and board draft horses on the 1.5 ha property. There are approximately 13 to 16 horses on site. The applicant states that they require staff on site at all times for routine care and in case of emergency. Due to personal circumstances the applicants require additional help onsite. The applicants are requesting that the original farm house be retained for farm help to care for the horses when the applicants are not available.

Conclusion:

The Commission understands that horses and other livestock require careful care for their health and well-being, however, the Commission believes that the number of residences located on the property should be commensurate with the level of agricultural activity on the property. Based on the information provided by the applicants, the Commission does not believe the present level of agricultural activity on the property is sufficient to warrant an additional permanent dwelling for farm help.
