**Re: Rescission of Stop Work Order**

This letter is in response to correspondence received from Mr. Coll Gordon of McKimm & Lott, dated February 28, 2013, regarding the July 19, 2012 Stop Work Order (the "Order") pertaining to the following properties:

(Civic Address: 191 Rainbow Road, Salt Spring Island, BC)

Mr. Gordon's correspondence was in response to my December 21, 2012 letter in which I provided the following advice:

*I am prepared to rescind the July 19, 2012 Order subject to the following:*

1. *Your clients providing written agreement that the area identified on the more detailed sketch will henceforth be the area of non-farm use excepted by subsection 23(2);*
2. *Your clients providing a written proposal outlining how they intend to demarcate the south and east boundaries of the excepted area. Please note that a simple method of distinguishing the excepted area from the non-excepted area is sufficient and can be done by constructing a fence, placing logs end to end, planting a hedgerow, etc.*

The information provided by Mr. Gordon satisfies the conditions precedent for rescinding the Order. Based on this information, as the Chief Executive Officer of the Agricultural Land Commission, acting pursuant to Section 51 of the *Agricultural Land Commission Act*, I hereby rescind the Order.
