

ORDER RESPECTING LANDS IN THE AGRICULTURAL LAND RESERVE (2022)

Definitions

1 In this order:

“**agricultural land reserve**” has the same meaning as in the *Agricultural Land Commission Act*;

“**authority**” has the same meaning as in the *Hydro and Power Authority Act*;

“**excluded area**” means the area excluded by section 2 from the agricultural land reserve;

“**mining official**” means any of the following officials under the *Mines Act*:

- (a) the chief permitting officer;
- (b) the chief inspector;
- (c) an inspector;

“**reclamation plan**” means a plan described in section 10 (1) of the *Mines Act*;

“**temporary exclusion maps**” means the attached maps dated December 20, 2021 and titled as follows:

- (a) Site C Temporary Exclusions from the Agricultural Land Reserve Detail 1 of 4;
- (b) Site C Temporary Exclusions from the Agricultural Land Reserve Detail 2 of 4;
- (c) Site C Temporary Exclusions from the Agricultural Land Reserve Detail 3 of 4;
- (d) Site C Temporary Exclusions from the Agricultural Land Reserve Detail 4 of 4;

“**Treaty 8 First Nations**” means the following First Nations:


- (a) Blueberry River First Nations;
- (b) Dene Tha’ First Nation;
- (c) Doig River First Nation;
- (d) Duncan’s First Nation;
- (e) Fort Nelson First Nation;
- (f) Halfway River First Nation;
- (g) Horse Lake First Nation;
- (h) McLeod Lake Indian Band;
- (i) Prophet River First Nation;
- (j) Sauleau First Nations;
- (k) West Moberly First Nations.

Temporarily excluded lands

2 All the land shaded black on the temporary exclusion maps is excluded from the agricultural land reserve until December 31, 2025.


Mines permits

- 3** A mining official must not issue to the authority a permit under section 10 of the *Mines Act* to carry out work on an area of land that is entirely or partially within the excluded area unless the permit includes a condition requiring that
 - (a) the authority must
 - (i) develop a revised reclamation plan in consultation and cooperation with the Treaty 8 First Nations, and
 - (ii) file with an inspector, within one year after the date the permit is issued, the revised reclamation plan, and
 - (b) the authority must ensure that any subsequent revisions to the reclamation plan are developed in consultation and cooperation with the Treaty 8 First Nations.








**Site C Temporary Exclusions






**Site C Temporary Exclusions


**Site C Temporary Exclusions
